(No Gift Policy)**

According to the Organic Act on Prevention and Suppression of Corruption, B.E. 2018, Section 128, no government official is allowed to receive property or any other benefits that may be calculated as income from anyone. In addition to property or benefits that should be obtained according to laws, rules or regulations issued by virtue of the provisions of the law. Except for receiving property or any other benefits in an ethical manner according to the criteria and amounts specified by the NACC. Set and in accordance with the Cabinet resolution on December 8, 2020 regarding the national reform plan. In terms of prevention and suppression of corruption and misconduct (revised edition), set out to drive the implementation of important reform missions (Big Rock). Reform activity number 4: Develop the Thai bureaucracy to be transparent and free of benefits. Goal 2, item 1.1, has units of Every state unit declares itself to be an agency that all government officials do not accept gifts and presents of any kind in the performance of their duties. No Gift Policy.

Laem Sak Subdistrict Municipality Therefore, a policy has been established for giving and receiving gifts during festivals according to ethics in order to strengthen the value of saving. Have the right attitude Create values of honesty in performing duties The personnel of Laem Sak Subdistrict Municipality must act as a good example as follows:

1. Personnel should not make demands. or receive a gift Property or any other benefits from those involved in the performance of duties This will cause the performance of duties not to comply with ethical standards. which may affect decision making in performing duties and must proceed in accordance with the policy for giving and receiving gifts as specified in the law Various regulations or announcements

2. Giving gifts according to traditional traditions The value of the gift must be in accordance with established laws and regulations. Also, you should refrain from giving gifts and presents. If giving influences decision making in performing duties

3. If there is a New Year's party May it be possible to create love, unity and morale among the group. Please keep it simple. It is not extravagant and takes into account the highest benefits for the Laem Sak Subdistrict Municipality Office and the public.

4. Commanders at all levels must behave and act as a good example. As well as supervising subordinate personnel to behave correctly regarding giving or receiving gifts or other benefits. Comply with the law Related regulations or announcements

5. Prohibition of solicitation among personnel. or use of any welfare funds of government agencies for providing gifts to superiors is strictly prohibited

6. You should use greeting cards. Signing the blessing book Use a congratulation card and wish on social media instead of giving gifts worth more than the legal limit. In order to strengthen the attitude of saving. Create values of thrift among personnel of Laem Sak Subdistrict Municipality.

7. To personnel of Laem Sak Subdistrict Municipality Strictly adhere to the No Gift Policy for giving gifts and receiving gifts during festivals while performing duties.
